# **Efficiency and Value for Money**

The Police Authority has set a plan to achieve £29m in efficiency savings over the three-year period 1 April 2009 to 31 March 2012. The target for 2009-10 was approximately £11m and this was exceeded by £2m as cash releasing savings were £5m and productivity savings were £8m giving a total of £13m.

## **Balances and Reserves**

The balance on the General Reserve as at 31 March 2010 was £6.2m representing 2% of the Net Revenue Budget. This is in line with the Medium Term Financial Plan.

### **Future Plans**

The Authority set a budget to spend £286.459m in 2010-11 on revenue expenditure. Since the budget was set, the government reduced grant funding by £2.8m which is being addressed through further value for money savings.

### **Summary of Accounts 2009-10**



### **Revenue Income & Expenditure**


The Devon & Cornwall Police Authority set a revenue budget for 2009-10 of £277.348m. Cash savings of over £5m were required to deliver a balanced budget and maintain police officer numbers at 3,500. The savings include a substantial reduction in police staff posts which were achieved by reducing "back office" services in Finance, Human Resources and Information and Communication Technology. The 2009-10 council tax charge for a standard band D property was £149.22, the lowest in the South West region and below the national average.

Actual spending for 2009-10 was £1.321m below the approved estimate. Of this sum £0.246m will be carried forward to meet committed expenditure that was not delivered by 31 March 2010. The remaining under-spend of £1.075m was put aside to help us manage reductions in central government grant funding in 2010-11 and future years.

### What the money was spent on 2009-10




When specific grant and income for services is added to general grant, total income for the Police Authority was £314m in 2009-10.

The Home Office categorises forces into 'most similar' groups. Within Devon & Cornwall's group, we have the above average officers per 1,000 population but below average council tax per head of population.



### **Capital Expenditure**

As well as day to day expenditure on running costs, Police Authority money is spent on assets such as buildings, vehicles, communications equipment and information technology. During 2009-10 capital spending was £17.5m. The chart and table below show how the money was spent and how it was funded.
